

## Radio 'Liberty' beams anti-S emitic broadcasts

WHEN RONALD Reagan appointed the far-right former Senator James Buckley to head Radio Free Europe-Radio Liberty, it was widely seen as an attempt to reorganize and fine tune the discredited Western European-based radio stations into better reflecting the policies and ideals of the Reagan administration

Radio Liberty in particular, with its fat multi-million dollar budget, is viewed as the heart of the program to transmit pro-capitalist values to the supposedly news-starved Soviet people.

In a story last month in the New Republic and in several articles by New York Daily News columnist Lars-Eric Nelson, more light has been shed

on just what those values really are. It seems that Radio Liberty, as it's called, has been regularly featuring pro-czarist, pro-Nazi and rabidly anti-Semitic commentaries under the guise of "religious" and "historical" analyses.

that Soviet-language programs are being broadcast from Radio Liberty by monarchists and former noblemen who left the Soviet Union either in the 1920s following the defeat of czarist armies by the Red Army or by pro-Nazi collaborators and Russian Orthodox clergy following the liberation of Nazi-occupied areas in the Soviet Union in the 1940s. They were recruited for Radio Liberty by the CIA.

Examples of Radio Liberty transmissions include a broadcast which attempted to rationalize several mass-

acres of Jews by the czarist army by noting that "many Jews had volunteered to join the Bolshevik cause," and that "it was difficult to restrain the indignation of the Cossacks."

Roman provincial prefect of Judea, "despised the Jews who denounced Jesus," as well as a program which was condemned by world-renowned Nazi hunter Simon Wiesenthal for praising a Nazi unit which spurred Ukranians into slaughtering thousands of Jews in the streets of Lvov. Others include a religious broadcast which asserted that Pontius Pilate, the Roman provincial prefect of Judea,

During a commentary on Alexander Solzhenitsyn (who was once described by Henry Kissinger as being more right-wing than the czar) and his book "August 1914," Pytor Stolypin, a des-

pised czarist prime minister, was described as "the pillar of the fatherland, the embodiment of best national features." Mordka Bogrov, who was Jewish and killed Stolypin in 1911, is described in the same commentary as "a cosmopolitan; he has nothing Russian in his blood or his character."

Despite vociferous denials of anti-Semitism by James Buckley, these are but a few of many examples of the racist and pro-fascist propaganda that is being pumped daily into the Soviet Union by Radio Liberty with the aid of our tax dollars. Is there any wonder why the Soviet Union tries to jam these transmissions so that this kind of filth doesn't soil its airwaves?

But perhaps, after all, they do represent the true policies and ideals of the Reagan administration.

To cause real harm, the Reaganites added another threat: to impose prejudicial tariffs on New Zealand exports of lamb, wool and casein, and to dump U.S. butter on the world market to compete with this important New Zealand export. Washington is counting on economic blackmail to whip its ally into line. About 13% of New Zealand's exports are to the U.S.

The Reagan administration is also looking to Australian Prime Minister Hawke to pressure Lange. Hawke, who is meeting with Reagan in Washington this week, had already written to Lange, asking him to betray his antinuclear position, just as Hawke himself did.

Late news reports on Feb. 5 stated that Hawke was informing Washington that Australia would have to cancel planned MX missile tests scheduled over that country. Despite Hawke's blatant pro-U.S. positions, he appears

constrained to separate himself from the U.S. nuclear buildup.

In Australia's last general election on Dec. 1, a new anti-nuke, environmentalist party took a substantial minority of Labor Party votes away from Hawke in the four districts in which they ran, where they got 4-7% of the total vote. The anti-nuclear issue has also united progressive, mostly European-background organizations with groups representing the original inhabitants of the area to protest urani-

um mining, for example.

For as long as New Zealand's 3.1 million people can resist pressure from the bully in the White House it will be an heroic example to the anti-nuclear movement worldwide.

## Loopholes give huge rebates ಠ General Dynamics, Boeing, others

FEBRUARY 4—How would you like to get a \$71 million tax refund?
While most people were busy forking over a sizable portion of their hardearned wages to the IRS, General Dynamics, the largest military contractor in the U.S., was gloating over a 1981-83 tax tab of minus \$71 million.

In other words, despite its \$931 million in profits over the same period, this giant arms manufacturer raked in a \$71 million bonanza in tax refunds, using loopholes in the tax laws.

Actually, General Dynamics hasn't paid a dime in federal taxes since 1972, although it reported more than \$2 billion in profits during that time. What's more, according to the New York Times (Feb. 1), the company is not expected to pay taxes "for some years into the future."

And this huge military corporation isn't alone. Other merchants of death like Grumman, Lockheed, Northrop and Boeing also have paid no taxes. Boeing, for example, got a whopping \$267 million refund from 1981 to 1983, while Northrop got \$42 million.

The loophole tailor-made for arms industry
The loophole that made all this possible is called "completed contract accounting." It is a lucrative loophole, tailor-made for the huge and powerful military industries, which thrive on fat open-ended government contracts.

"Completed contract accounting" allows companies with long-term contracts to deduct many of their expenses on those contracts immediately, while deferring almost indefinitely paying taxes on revenues and profits from those contracts

that the average tax rate for the top 12 military industries for 1981-83 was only 1.5%—hardly the fair share of these money-hungry bloodsuckers. The result of this loophole has been

"Completed contract accounting" predates Reagan although the President has hardly stopped it, despite all his claims of "closing loopholes." When Reagan talks about "closing loopholes," what he means is taking away the few deductions that working and middle class families have, such as those based on interests for car

stitute the most audacious giveaway to the big corporations in U.S. history. While corporate income taxes in 1945 made up almost 40% of federal net revenues, by 1982, the year after Reagan announced his tax plan, the corporate share had fallen to only 11%.

According to the AFL-CIO, over half of Reagan's highly touted 1981 tax cut went to big business and the wealthiest 10% of the population, while poor and working people who can afford it the least, continued to bear the bulk of the Joans and mortgages In reality, Reagan'

Reagan's new tax scheme

And if tax inequities aren't already bad enough, now Reagan has a new scheme up his sleeve which will make it even harder for working people, tax "simplification." Despite its misleading name, this scheme is just more of the same: the rich will get taxed less and working people will be made to shell out even more.


Reagan, who once bragged that he thinks corporations shouldn't pay any

ment insurance, medical benefits and all union benefits, to take away tax credits for the elderly and to count sick days and vacation days as income, among other anti-people provisions.

With the lion's share of federal revenues going to the military budget, guess who eventually ends up with all the tax monies paid by poor and working the same of the s taxes, is proposing this year that the tax law be altered to tax unemploy-

Besides the big banks (which have their own loopholes to get out of paying taxes and which enjoy exorbitant interest payments from the government on the federal deficit), it's none other than the military industries who end up with the dough from the taxes, thanks to their willing servants in the capitalist government.

Working and oppressed people have no interest in seeing their tax money spent on weapons of destruction to protect U.S. corporate profiteering abroad. It is time to put an end to this tax monies for job and social services, not for war

## Military opponent brass of Viet persecuting Nam

Keith Mather imprisoned for 1968 protest

FEBRUARY 5—On Christmas Eve of 1968, Keith Mather, a 21-year-old Army private, escaped from the Presidio Stockade where he was serving a prison sentence for the "crime" of demonstrating against the Viet Nam war.
On Dec. 9, 1984, Mather, now 38 years old and the father of two children, was arrested in Half Moon Bay, Calif., by Military Police who took him to Fort Ord to serve out his 18-month

sentence.
Behind this vindictive persecution by the military brass of an individual, after the passage of 17 years, is one of the truly dirty episodes of U.S. military

It all began on Oct. 14, 1968, with what the military high command came to call the Presidio Mutiny and the anti-war movement called the case of

anti-war movement called the case of the Presidio 27.
On that day the prisoners at San Francisco's Presidio Stockade were as-sembled for roll call and work-detail assignments at 7:30 a.m. When the

first name was called, they answered "here" in unison, walked over to a grassy corner of the stockade enclosure and sat down, protesting the murder of a 19-year-old fellow inmate cut down by a guard's shotgun blast three days before when he made a break for free-

The stockade commandant approached the sitting prisoners, among whom was Keith Mather, and read them Article 94 of the Uniform Code of Military Justice, the section dealing with mutiny. When the prisoners still refused to move, this Army captain called in MPs and fire equipment and ordered the 27 men hosed down.

The soldiers operating the fire equipment refused to obey him. The MPs then carried the demonstrators back into the stockade barracks.

Captain Richard J. Millard of the United States Army Quartermaster Corps, commissioned by the brass to conduct a pretrial investigation of the men, recommended in his report that "to charge these soldiers with mutiny,"

Columbia progress. With the word out that a National Labor Relations Board (NLRB) decision on union certification at Columbia University is imminent, the school signed an agreement with UAW District 65 on Jan. 30—pledging to abide by the NLRB decision and to refrain from unilateral wage and benefit changes in the meantime. Columbia maintained that the agreement did not amount to recognition of District 65 as the bargaining agent for clerical and technical workers, but the workers consider the document, signed by the administration and the union, a victory in the fight for unionization. The agreement also commits Columbia to bargain with the union on issues of pay equity, affirmative action, health and safety, and other benefits if no NLRB decision is announced by May 4; and a grievance procedure permitting union

representation is also included. The Columbia workers responded to this development by calling off strike plans for now, while crediting the strike mobilization with forcing management to move.

Commission vs. civil rights.
The federal agency charged with monitoring and enforcing civil rights laws has been found guilty of discriminating against a woman worker. A federal district judge in Atlanta, Ga., ruled that Miriam Nalebuff Grayboff was a victim of sex discrimination by the U.S. Commission on Civil Rights, and awarded her \$26,000 in back pay. Grayboff worked at the Commission for

eight years, during which time she performed the same work as several male co-workers who were in higher salary grades. The Commission claimed that the discrimination was unintentional. But the judge said that claim "strains credibility." The ruling comes at a time when the Commission, packed with Reagan appointees, is moving full force to take the side of racism and sexism against affirmative action, quotas, and civil rights enforcement.

# Puerto Rican nation mourns another freedom fighter

Don Juan Antonio Corretjer 1908-1985

ON JANUARY 19, the nation of Puerto
Rico lost a leader and national liberation fighter—Don Juan Antonio Cor-

Don Corretjer was born in the town of Ciales in Puerto Rico, on March 3, 1908. While only in the 8th grade, he organized the first student protest against U.S. authority in Ciales.

In consequence, he was excluded from attending local schools and had to go to another town to study. In his teens, he joined the young cadres of the Nationalist Party where he continued his activities within the student movement. During the years 1926-7he was introduced to Marxism through his reading of "Capital."

In 1928, he went to New York where he joined the Anti-Imperialist League of the Americas, which was part of the Third International. During this period, he joined protests against U.S. intervention in Nicaragua and Haiti. He also worked with the Sandinista Front to gain sympathy and support for the involved in these activities, he was arrested by U.S. authorities.

## Fought alongside Albizu Campos

By 1930, Corretjer returned home to Puerto Rico. At the same time, another great Puerto Rican liberation fighter—Don Pedro Albizu Campos—had returned to the island after a tour of Latin America where he had raised support for the independence movement of Puerto Rico. Don Pedro was the president of the Nationalist Party at the time; Corretjer became its ad-

ministrative secretary.

Both participated in the 1932 popular protest against the U.S. ban of the Puerto Rican flag and the 1934 islandwide sugarcane workers' strike. A year later, Corretjer went to Cuba.

At the time, Cuban workers were conducting a strike, which was antimperialist in character. As the U.S. threatened military intervention in response, Corretjer supported the Cuban people and answered the U.S. on radio, where he said, "The Cuban people will receive you with arms in their hands."

Rico, he entered the tremendous struggle engulfing Puerto Rico in its fight against U.S. military occupation of his country. He was named Secretary-General of the Nationalist Party.

The Nationalist Party, under the leadership of Don Pedro, was waging an armed struggle to free the island from the domination of U.S. imperialism. In this struggle, both Don Pedro and Don Corretjer were arrested along

with many members of the Nationalist
t Party on charges of trying to overthrow the U.S. government.
At the trial, at which the Nationalists demanded a jury of their peers,
they were found innocent. But the U.S.
government retried them with a specially selected jury. Corretjer and Don
Pedro, along with other Nationalist

Party members, were sentenced to seven years in the U.S. federal penitentiary in Atlanta, Ga.

The harassment of this hero continued and in 1969 he was re-arrested in Puerto Rico, along with his wife and fellow compatriots, and charged with

In the last years of his life, Don Corretjer continued to struggle. He helped bring the case of the colonization of Puerto Rico by the U.S. to the United Nations and fought against the U.S. military draft, which forces Puerto Rican youth into fighting U.S. wars of aggression. He aided the struggle against the U.S. Navy's use of the island of Vieques, and against the U.S. strip-mining and exploitation in Puerto Rican women, and he supported workers' strikes and unions and condemned U.S. intervention in Latin America.

Don Corretion continued to the end

Don Corretjer continued to the end of his life to struggle to see his homeland free from U.S. imperialism. He never stopped, and sacrificed hours of his life and family for the struggle.

Don Corretjer embodied the slogan La Patria es Valor y Sacrificio (The homeland is valor and sacrifice). Puerto Rico and the people will miss you.

FEBRUARY 5—Deep into the interior of Brazil, along the Jamari River at the site of the Pompeia Mining Company, an encampment of geologists (mineral & rock experts) were attacked by 50 Native people whose land they were exploiting.

Two geologists were killed by poison-tipped arrows in the attack. Even the government's Indian Foundation was forced to admit that this was "probably a warning to stop penetration of lands they control."

Native people of the Amazon in Brazil are threatened with extinction. Re-

ernment are displacing thousands of indigenous people.

The region is being penetrated by huge mining, chemical, timber and

huge mining, chemical, timber and other exploiting companies. In addition, poaching of unique wildlife is wiping out what little animal life still remains. The Brazilian government looks the other way while the countryside is encroached with the trafficking of cocaine, gold, and armaments.

At the same time rivers and lands are poisoned by the mining and chemical companies. As mining increases in the region, the mercury content of the rivers worsens. Despite the toxins poisoning the area 14 alcohol fuel plants are authorized for construction.

While today the Native people of the Amazon are fighting this imperialist penetration with the only weapons they have at hand—poison arrows—history shows that the united strength of all the oppressed will ultimately triumph over the oppressors.

Keith Mather returned to the U.S. in 1980, got a job as a union carpenter under his own name, and worked quietly supporting his children until his arrest by the Army bloodhounds. These Captain Queegs can never for give him for his role as an anti-war GI and leader of the Presidio 27.

"They still want to relive the Viet Nam war," Mather's lawyer, Howard De Nike, told Workers World.

After being placed in the Ft. Ord Stockade, Mather received a serious injury, putting him in a coma. He has now recovered and is currently being held in the Ft. ## Michigan State budget: attack on poor

By Jerry Goldberg
DETROIT, Feb. 3—Despite an unemployment rate which continues near 11% in general and 26% for the Black community, and the highest Black infant mortality rate in the country, Michigan Governor James J. Blanchard last week declared that "Michigan is the comeback state." He then outlined a budget which intensifies the assault on the living standards of poor and working people

and working people.

The Blanchard budget proposes a \$130 million cut for the Department of Social Services. According to him this means that welfare benefits, which have not been raised since 1979, will remain "frozen."

This welfare "freeze" assumes that

the next year and that there will be an increase of \$150-to-\$200 million in federal aid. Considering that the Reagan administration is proposing its own large-scale slashes in social services as well as revenue sharing and that many economic forecasts are pointing to an increase in unemployment, it seems highly unlikely that any real budget could be based on such weak assumptions. What is more likely is that Blanchard's proposal will result in a cut in welfare benefits.

While welfare for the poor is being drastically cut, welfare for the rich is what government is all about. Despite record profits, huge corporations like GM, Ford and Chrysler pay virtually

Continued from page 1 ing the electric chair for Goetz instead of hailing him as a hero."

The over 100 people who picketed Manhattan Criminal Court braved gusty winds and icy cold streets as well as the harassment of right-wing news reporters and cops. For over an hour, the street block, which is usually crammed with cops, judges, lawyers, DAs and other accessories of the court system, was converted, in the words of one demonstrator, "to an anti-racist block. The racist elements were intimidated and a lot of people, especially a lot of Black and Latin youth going in and out of the building, gave us fists in support."

As Goetz was being whisked in and out of the court for his five-minute arraignment, demonstrators' chants of "Stop racist violence against the Black community" could be clearly heard inside the 11th floor courtroom

Goetz was arraigned on minor gun possession charges because a grand jury last week refused to indict him for attempted murder even though when Goetz first turned himself in to New Hampshire police he admitted that he never felt threatened or even afraid of

The assistant attorney ed at the time, "There is pre-meditation." y general stat-is evidence of

pre-meditation."
At the end of Goetz' court hearing Judge Stephen Crane ordered the would-be killer's bail reduced from \$50,000 to \$5,000 as one spectator stood up and yelled, "Goetz, you're a racist!"

Goetz, the son of a millionaire, is a high-paid engineer who does work for the Pentagon. One of his victims, 18-

year-old Darrell Cabey, is now in a coma and paralyzed from the waist down. Two of the other youth he fired at were shot in the back.

A leaflet handed out this morning by the All-Peoples Congress, a nation-wide group that seeks to unite poor and working people around a program of fightback against the Reagan program of cutbacks, racism and war, pointed out that "politicians, like Koch or D'Amato, who feel that it should be open season on Black youth in the subway because "their very presence is menacing," don't really care about crime. Is unemployment not a crime? Unemployment is 70% to 80% among Black and Latin youth in New York.

We need jobs—not racist vigilantes, killer cops and more jails!"

Demonstrators also raised the cases of Michael Stewart and Eleanor Bumpurs, two recent Black victims of police murder. Mr. Stewart was a 25-year-old artist beaten to death in the subways by transit cops who arrested him on a graffiti violation. Mrs. Bumpurs was gunned down by two blasts from a 12-gauge shotgun as city cops tried to evict her from a city housing project for being late with her \$96-a-month

wants to give them even more. Blanchard is proposing a large business tax credit program which amounts to an \$80 million gift to big business. When GM announced its Saturn project, Blanchard offered them millions in tax breaks to stay in Michigan. Blanchard is also pushing to tighten eligibility for workers' compensation benefits while at the same time cutting these

The second area slated for cuts by Blanchard is the Department of Labor, which deals with union disputes.

Blanchard is increasing certain areas of the Michigan budget. He is calling for an increase of \$178 million for K-12 education and \$120 million for colleges. While that sounds good, a study conducted by the National Coalition of Advocates for Students which was released only last week pointed out that millions of public school children—the poor, minorities, young women and the disabled—are suffering at the hands of an uneven education system historically tilted to the well-off and headed even further in that direction

The fact that Blanchard's education proposals are so well received by the most right-wing legislators indicates that his proposals undoubtedly follow that trend. Moreover, most universities in Michigan have become all-white enclaves as affirmative action programs won through the struggles of the 1960s have been virtually wiped

One area, however, is slated for a big increase—law and order. Millions are being proposed for more state cops and prisons.

What's interesting about this new budget is that the state of Michigan is currently enjoying a budget surplus.

But who is to benefit from this surplus?
Blanchard is proposing a \$65 million rebate on property taxes. Naturally, the biggest property holders, the cor-

the biggest property bakes. Naturally, the biggest benefit from this rebate. To lay the groundwork for passage of this "take-from-the-needy-to-give-to-the-greedy" budget, the state, with collusion from the media, has launched a tremendous propaganda offensive against the poor. Hundreds are being indicted as "welfare cheats." Newscasts are filled with reports on the "welfare problem."

The right of the poor to Medicaid abortions may be overturned. Next week the Michigan House is expected to join the State Senate in banning state funding for Medicaid abortions. While Blanchard will veto this, he is not seriously trying to stop that veto from being overridden. State legislators are also proposing that General Assistance be eliminated for six months out of the year.

Union leaders and welfare rights leaders have been silent or at best defensive in their answers to this full-scale assault. Why? Blanchard is a Democrat who was elected with the support of these forces. They continue to ignore the most important lesson of capitalist politics: The Democrats, just like the Republicans, are controlled by the rich bankers and powerful industrialists and ultimately represent their interests over the interests of the work-

ment independent of the Democrats and Republicans, which unites all poor and working people. The Michigan Constitution provides that "the health and welfare of the people are the primary concern" of the state. It's time to take mass action to enforce this right. ers and poor.

## NYC mayor grand jury 9 **Bumpurs** blasts case

By Kobert Dobrow NEW YORK, Feb. 5—The racist stench from City Hall got a little thicker this

In the wake of the media hype over dependent of the media hype over white engineer who shot down four Black teenagers in a subway car who were "harassing" him for \$5, the Koch administration and the cops have launched a hate campaign against a Bronx grand jury which last week insdicted the cop who gunned down a 66-ty year-old Black woman, Mrs. Eleanor Bumpurs.

Last October's killing of Bumpurs during an eviction from her apartment in a city housing project created a storm of protest in the Black and Latin community. Bumpurs had been late with her rent of \$96.25.

The cops claimed that Bumpurs had been killed by just one shotgun blast. Woch's Chief Medical Examiner a Dr. Elliot Gross, who is under investigation for falsifying autopsy reports in favor of the cops, then ordered that Pearl's autopsy be reworded to leave open the possibility that she was hit by only one blast.

The Bronx grand jury based its indictment on second-degree manslaughter contract of two shotgun had been here we widence of two shotgun

The grand jury's findings drew immediate fire from the city government and the police department. Mayor Koch expressed his "sadness" over the indictment. The head of the Patrolmen's Benevolent Association at-

tacked the jury as "racist" (!) because there were 11 Black and two Latin jurors and "only" 10 whites. All 252 officers in the Emergency Service Unit of the police department are now threatening not to work in their unit any longer and urged other cops to do likewise in protest of the indictment.

Within 24 hours after having been suspended from his job, the cop was reinstated and given a cushy job at police headquarters in Manhattan—another official green light for police brutality and murder of Black and

people.

At the same time, according to the New York Daily News (Feb. 5), the Bronx grand jury sent Mayor Koch a letter blasting the role of his administration in the Bumpurs killing..

The letter particularly decried the actions of the Human Resources Administration (HRA) as "evidence of an agency which appears to have many arms but no head."

It further hit the New York City Housing Authority (NYCHA) for initiating the eviction proceeding at all, noting that "many questions" remain over whether Bumpurs ever actually received notice of her eviction.

The grand jury suggested that the NYCHA should have advised the HRA of Bumpurs' predicament and "coordinated the effort to obtain an emergency maintenance nayment for her"

gency maintenance payment for her."

"Certainly, the forced removal of an elderly woman from her \$96-per-month apartment should occur only as a last resort," the jurors protested to Value.

process."

Actually, from a working class point of view there is not one budgetary process."

Actually, from a working class point of view there is not one budgetary process but three. Although the three are intimately interrelated, each should be examined independently in order to bring out its true significance as far as the mass of the people are concerned. The budgetary process to which the ruling class, the capitalist politicians, and the media refer is the purely legal, procedural and parliamentary aspect of pushing through a budget.

In reality, this is the superficial aspect of the budgetary process. It is the aspect which hides the real process, which is a social process.

## Capitalist state: collective exploiter

of the people

To understand this, one must look at the relationship of the basic classes in capitalist society. This is a process by which the capitalist state in its role of the collective exploiter and oppressor of the people collects, or to put it more accurately extorts, from the mass of the workers and the people generally that which the individual capitalist exploiter cannot directly expropriate from the workers. The capitalist state in its role as the collective agent for the ruling class expropriates the rest of what is left and distributes it among the various ruling cliques through what they call the budgetary process. In addition the capitalist state also adds an onerous form of extortion through taxes against the people while exempting from this taxation most of the ruling class who at best only pay a token amount.

token amount.

The budgetary process is therefore a means for dividing up the surplus value created by the workers and distributing it among the most predominant monopolist ruling groups. In this role, its economic role, the state can only superimpose upon the individual, direct exploitation of the working class, the collective, indirect exploitation by the collective exploiter of the ruling class—the capitalist state.

organization of masses

The third aspect of the budgetary process involves the mass of the people, the working class and oppressed and how they are organized in the struggle against this extra form of capitalist exploitation.

The bourgeoisie attempts to present the budgetary process in a narrow and purely procedural way so as to hide the actual social class content of the economic process, that is, of the relationship between the exploiter and exploited as embodied in the capitalist state.

The Constitution of the United States, Article 1, Section 7.1 states: "All bills for raising revenue shall originate in the House of Representatives." Is that what really happens in contemporary times under the domination of finance capital, giant multinational corporations and the military-industrial complex? Not at all.

Who develops the real budget?

The real budgetary process is initiated, discussed, worked upon and developed by about 25 and at most 30 of the biggest Wall Street and Washington law, accounting and tax specialist firms which represent the most powerful interests of the largest and mightiest of the financial, industrial and military corporations of the U.S.

These servants of the ruling class

with the White House, the Internal Revenue Service, the Treasury Department and key members of the Senate and House of Representatives. They are retained on long-term contracts, retainers that is by the giant

I hese so-caused ong name raw, accounting and tax specialist firms know well the intricacies of governmental processes as they relate to taxation and the appropriation of money. Representatives of these law, accounting and tax firms and government officials literally know each other on a first name basis. The bourgeois elite among the country stop accounting and law firms are tied by a thousand threads to the highest government officials, whether they be in the White House, Internal Revenue, the Treasury or whatnot.

Most of the representatives of these law and accounting firms have in one way or another served in key capitalist governmental agencies including the IRS, the Treasury and the White House. They go back and forth from these departments with the ease and facility with which one might travel on a train or plane.

Thus when you hear that a giant corporation like General Dynamics, just to mention one out of several dozen, hasn't paid a cent in federal taxes since 1972, it's precisely because the agents in these giant taw and accounting firms are paid fat fees to maintain an intimate connection with the capitalist government while seemingly remaining aloof from it.

What individual Representative or Senator could even hope as an individual to go through the ten thousand and one items that are supposed to be listed in the budget? Only a giant firm could do that. Only a financial organization with hundreds of employees and intimate governmental connections over a long period of time and experience with Democratic and Republican administrations can manage such a monopolies.
These so-called big name law, ac-

wields the most powerful influence as servitor for the big bourgeoisie, the finance capitalists who fleece the workers and the oppressed.

What then is the task of the Congress as revealed in the actual framework of class relations and not merely as they are superficially and fraudulently represented through the purely procedural aspect of the budgetary process? It is more that Congress is increasingly reduced to the level of a talk shop while the real work is carried out behind the scenes, and the role of the people is not taken into account at all except in those cases where the ruling class becomes fearful of genuine mass pressure exerted from below.

What is the quintessence of the ruling class' budgetary problem today? It is how to put across the Reaganite budget. This budget is a truly horrendous form of expropriation of the savings of the masses and of further intensifying the exploitation and oppression of the masses in such a way as to give the appearance of having arrived at a consensus of the people.

Thus a whole lot of complicated maneuvers are now going on in which a whole variety of capitalist politicians from the extreme right as well as among the liberals allegedly vie with

among the liberals allegedly vie with each other in cutting down or reducing the budget.

In reality, however, while dozens upon dozens of Congresspeople are scurrying to their districts and whole regions presumably to get input into the budget, a rotten compromise has already been achieved behind closed doors in order to obtain the so-called necessary trimmings of the budget so that at the end of the process it will appear that a good, hard fight was put up against the Reaganite mass expropriation of the people. Of course, the bulk of what the Reaganites and especially the Defense Department asked for has already been agreed to.

to increase defense expenditures'

Listen to that most liberal Senator,
William Proxmire from Wisconsin,
and Representative Pat Schroeder
from Colorado who were both asked to
respond to Defense Secretary Caspar
Weinberger who presented the Reaanite military budget—the largest,
most unprecedented in U.S. history.
Asked to define the issue as far as defense expenditures go by Sandy Freeman on Cable Network News (CNN)
on Jan. 30, Proxmire replied that the
issue in Congress is "not whether to
reduce expenditures. I want to make
that clear. I know of nobody outside of
perhaps Jesse Jackson or George McGovern, neither of whom are in Cone gress, who would reduce defense expenditures. The real issue is how much
to increase defense expenditures. We
are for about 3% and the administration is for about 7%. So it lends itself to
a consensus and compromise."

There it is in a nutshell. First of all
the real issue as defined by Proxmire
(and he should know because of his
long time in Congress) is not how to
reduce the burden of the gargantuan
war budget but by how much to in-

crease it.

Rep. Schroeder, who like Proxmire sits on one of the armed services subcommittees, agrees with him. "No one," she says, "wants to weaken our defense. We want to strengthen it." But again the question is by how much. From a working class point of view it is very necessary, in fact it is absolutely indispensable, for every worker, fo

## ð Reagan offers military-industrial huge handout complex

FEBRUARY 4—The budget President Reagan sent to Congress contains the largest request for military spending in the history of the United States, more than double what the Pentagon received in 1979. The heaviest outlays are earmarked for nuclear missiles and the Star Wars system.

Calling for an end to "government by handout," Reagan has prepared a handout for the military-industrial complex that includes every weapons program dear to the heart's desire of some general or admiral.

There's \$313.7 million for the Stealth Bomber, more Pershing 2 and cruise missiles for Europe, a massive step-up in chemical weaponry, 48 more MX missiles at a cost of \$4 billion, another \$624 million to develop the Midgetman missile that can be shot from a flatbed truck, five new attack submarines and one Trident nuclear submarine costing \$1.7 billion, an additional \$8.2 billion for the Department of Energy's hydro-

gen bomb and nuclear warhead production line, \$1.16 billion for the Grumman Corporation's contract on F-14 Tomcat fighter planes, \$6.2 billion for 48 more B-1 bombers, \$39.3 billion for research and development, 15,000 more sailors for the Navy and 13 new surface ships, 10,000 more airmen along with additional C-5 and KC-19 cargo planes, a rapid-deployment "light" division for the Army and 144 Apache attack helicopters, 840 new M-1 tanks and 716 Bradley fighting vehicles.

"Secretary Weinberger feels," according to a statement released by the Pentagon, "that those who hope for success in bringing down the defense budget really mean success in weakening the security of the country."

What Secretary Weinberger really feels is that he can shut up any opposition to this grotesque \$313.7 billion war budget by red-baiting smears and flagwaving hints that those who don't go along are secret traitors.

Now as far as the Democratic Party politicians in Congress are concerned, none of the leaders there are even suggesting a cut in military funding, but only a slightly smaller rise in the rate of increase. This is the position of Jim Wright (D-Texas), Tip O'Neil (D-Mass.) and so-called Republican moderates like Bob Dole (R-Kan.) as well.

All are either unwilling or unable to stand up and really resist the rich defense contractors, the generals and admirals, and the Reaganites who serve them. In effect, the legislative branch has been turned into a kind of rubber stamp for whatever the military-industrial complex demands.

Whatever pressure the members of Congress are under to swallow these wild "requests" from the Pentagon, it does not come from the majority of people who have shown in one public opinion poll after another that most believe military outlays are already far too high.



Those people who speak about arriving at a "compassionate mix of defense cuts and domestic cuts" are hypocrites who are deceiving the people and are no better than those who are talking for "fiscal responsibility" by which they mean financial responsibility to the ruling class, balancing their budgetet—not the budget of the workers, the multimillion oppressed. Our budget, the budget that the worker has to consider every day, every week, is not what these hypocrites are concerned with. They want to convey the impression that the capitalist budget of the ruling monopolies which the Congress is supposed to be sweating over is really our budget when this is not at all the

Concerning the last budget that the Reaganites put across which caused so much untold misery to millions of workers and oppressed people, Chris Wallace, White House correspondent at NBC News, said on Feb. 4, "96% of Reagan's, budget was agreed to by

Congress."
So all the bickering, all the negotiating, all the sweating concerned a mere 4%. The rest was precisely what the Reagan administration had asked for. Yet it is the third process, that of mobilizing the masses, that has to be considered in light of the fact that no appropriation bill can be effected without the consent of the House of Representatives, where the money bills are supposed to originate in the first place.

The House of Representatives is still Constitutionally, that is legally, the ultimate power concerning the appropriations of money. It still holds the



legal power over the government's financing. No budget can be passed without its consent.

Democrats a majority in House and must be held responsible

Notwithstanding all the machinations, regardless of all the secret and not so secret dealings between the Reaganite government and the Congressional leaders, the army of lawyers, accountants and tax specialist firms in the pay of the huge multinational corporations and banks, at the present time as for the past six to eight years at least, when all is said and done, the Democratic Party is the majority party in the House and should be held responsible. They all ran on a program against Reaganism. Whether they meant it or not is not the issue. They did run against Reaganism.
They said they were against Reagan's defense program, against cuts in Medicare and other life-supporting programs for the masses.

Should not attention be focused, indeed riveted, upon a majority of the House which promised to fight the Reaganite budget? Should not atten-

tion be drawn to the efforts to forge a rotten, reactionary and racist compromise on the Reaganite budget? Without in any way cultivating parliamentary illusions regarding the nature of the capitalist government, is it not correct to focus in on the pledge made by the majority of the House? Or should they be let off the hook? Should this be passed over in silence and no fight be put up to compel them by mass pressure to live up to their pledge?



In Chicago, officials warned that the cut would mean they "could quickly face a shutdown crisis" and New York City officials immediately warned of a major fare hike and further service reductions on the deteriorating subway and bus lines. The transit association estimated that the loss of the federal subsidy would mean the elimination of 203,000 jobs nationwide from service and construction cutbacks.

Another vicious blow is a 28% cut from the Labor Department's Employment and Training Administration and the complete elimination of the Job Corps. Reagan's first year in office marked the death of the CETA program, the last large scale jobs program, and jobs programs have been treated like some kind of disease by the

administration ever since. These final nails in the coffin of job

training and placement assistance come right after news that unemployment rose for the second month in a row. While Reagan's figures show that unemployment rose from 7.2% in December to 7.4% in January, other economists have charged that a deceptive "seasonal adjustment" was used, and that the raw figures show that unemployment actually rose to 8% last month.

## border Nicaragua's S.-Honduran maneuvers resume

By John Catalinotto FEBRUARY 5—Even as Nicaraguan President Daniel Ortega Saavedra warned of the growing danger of U.S. military intervention against his country news was released about the

resumption of joint U.S.-Honduran military maneuvers near the Nicaraguan border.

President Ortega noted that the Reagan administration had broken off the bilateral talks with Nicaragua that had been taking place in Mexico; that the U.S. had withdrawn from a case in the International Court of Justice on a

Nicaraguan suit charging U.S. aggression, and that Washington had stopped giving any backing to the Contadora talks involving Mexico, Panama, Venezuela and Colombia.

"All of these point to the fact that the administration has not decided in favor of a political solution and has not discarded a military solution," Ortega said in a Feb. 3 interview with the New York Times. He explained that his government was "still obliged to think that the danger of an invasion is present" and that the Nicaraguan people would keep up their guard.

A number of times in the past few years the Reaganites have ordered itroop and ship movements which threatened Nicaraguan borders, cordinating these deployments with a campaign of slander against the Sandinista government in Managua. Although each time so far the Pentagon stopped short of a direct attack, the threat itself required the Sandinistas to keep the nation on a war footing, to let Washington know that any such invasion would bring many U.S. casualties is a major deterrent to the rabid Pentagon planners who dream of another Grenada-type assault on Central

Aid to contra thugs
Ortega also directed his comments to the attempts by the Reaganites to resume open U.S. aid to the 10,000-15.000 contra thugs who have been contra thugs who nave with sing Nicaraguan people and ging their economy. He said murdering N sabotaging 1

such a resumption would be "extremely grave for the future of negotiations in Central America. That would bring us closer and closer to direct acts of aggression by the U.S. against Nicaragua, and then the U.S. administration would feel that it has bipartisan tion would feel that it has bipartisan support for its more aggressive policies here," the Nicaraguan president

asserted.
Although the U.S. Congress last year suspended funding for the contras, "private funding" from U.S. millionaires, retired Pentagon officers and right-wing emigres give them up to \$1 million a month to carry on the murders. At the center of this rightist cabal is the notorious Gen. John Singlaub, president of the "World Anti-Communist League" and formerly in charge of the U.S. forces in Korea. Singlaub is "retired," but other top Pentagon officials like Fred Ikle and Nestor Sanchez are helping to coordinate his efforts, Singlaub himself admitted. (Miami Herald, Jan. 21)

## Pine III

A concrete sign of more aggressive policies from Washington was the notice that from Feb. 11 to early May the joint U.S.-Honduras military exercises known as Big Pine III would be taking

These exercises are to be centered near San Morenzo, on the Gulf of Fonseca, about equidistant between Nicaragua and El Salvador. It gives access to the only area of the Honduras-Nicaragua border that is flat and easily

U.S. and 3,000 Honduran troops will be using M60 tanks and armored personnel carriers. And the U.S. is allowing no press to be near the exercises.

U.S.-Soviet talks

When asked if the coming U.S.USSR arms talks might improve the international situation and relieve U.S. pressure on his government, Ortega said on the contrary that the talks could even increase the danger.

"The fact that the arms talks are occurring could bring some people in

**PERU.** In preparation for the Pope's arrival, the Peruvian police rounded up thousands of prostitutes in the eight cities scheduled to be visited by the Pope. An additional 2,000 individuals presumed by the police to be "subversives" were also arrested. Yet despite the extreme security measures taken by the police and armed forces, the capital city of Lima and other cities were blacked out hours before the Pope's arrival. The power failure was caused by the blowing up of electrical power lines by the Shining Path guerrillas.

pominican weekers' Party and the Source arrested trade of a growing protest of gasoline price increases dictated by the government last month, "huelgas-populares" (people's strikes) organized by neighborhood committees have spread to 50 locations across the country. A general strike has been called for Monday, Feb. 11. In an attempt to repress this struggle, Dominican troops and police arrested trade union and leftwing leaders Feb. 5, including leaders from the Communist Party and the Dominican Workers' Party.

Fuel and food price increases of as much as 70% had been set by the IMF as conditions for approving a loan.

## Lebanon withdrawal from Sraeli forces Resistance

FEBRUARY 2—The surprise, unilateral announcement by the Israeli government that it would begin a phased withdrawal from southern Lebanon this month is a clear retreat.

The huge, U.S.-supplied military

This rampage began following the explosion of a car bomb at the site, inflicting casualties on at least ten Israeli soldiers. Follwoing their usual policy of savage reprisals against unarmed civilians, the troops immediately surrounded Burgel Shamali, cut off all electric power, announced a curfew and then stormed in with guns blazing.

According to early reports from the UN Relief Works Agency, the victims included a 6-year-old child, a 38-year-old woman and at least six others.

An Israeli military convoy passing the camp also joined in the firing.
Who is responsible for this outrage?
Certainly the Israeli government cannot shed responsibility for the actions of its military units in Lebanon. Nor can this atrocity be passed off as "an

isolated incident," since periodic outbursts of extreme violence against Arab civilians under Israeli army rule has been common right from the time the settler state was set up in 1948.

But the guilt is not Israel's alone. When its army invaded Lebanon in the summer of 1982, it smashed across the border with artillery, tanks, trucks and aircraft provided by the U.S. government. The high-explosives and fragmentation bombs which rained down on the population of Beirut throughout July and August of that year also came from the Pentagon arsenal.

And Washington's diplomatic clout has been ever-present as well, most recently last fall when the U.S. delegate to the UN vetoed a Security Council resolution introduced at the request of the Lebanese government condemning the Israeli Army's systematic oppression of civilians in occupied southern Lebanon. To condemn Israel while ignoring the role of U.S. imperialism is to fouce on the pawn instead of the

## Ethiopia being used U.S. imperialist aims Jewish people from to further Zionist,

Ey Michael Bar-Am campaign directed against revolutionary Ethiopia by U.S. imperialism has had a devastating impact on the small, 25,000-member Ethiopian Jewish community. Families have been broken up forever, thousands have died of starvation and thousands of others have left their homeland.

Most Ethiopian Jewish people live in the northern province of Gondar. It borders on the Sudan, which is a staunch U.S. ally. Before the 1974 revolution, when Ethiopia was ruled by a U.S.-Israeli-backed feudal monarchy, Jewish people could not own land. They were only allowed to work as sharecroppers, craftspeople and metal workers.

Since the revolution, sharecropping and land has been distributed to all the peasants. Laws restricting Jewish participation in the economic and social life of Ethiopia are no more.

Implementing land reform and other revolutionary advances has been especially difficult in Gondar. The province has suffered from a severed rought which has caused widespread famine. Also, U.S.-backed counter-revolutionaries, similar to the "contras" in Nicaragua, made up of the dispossessed landlords and their lackeys, continue their attempts to destabilize the revolution.

## PRISON BRIEFS

Uprising in Indiana

FEBRUARY 1—A 12-hour uprising of prisoners held in the maximum security section of the Indiana Reformatory ended on Feb. 1. Prisoners said that beatings by guards ignited the rebellion.

Prison officials agreed to negotiate a list of 22 demands, including amnesty, the establishment of a grievance committee, the right of prisoners to be politically active without intimidation or reprisal, and the right to air their demands publicly. Despite this promise, the media has paid little attention to the prisoners' demands.

## Yonkers jail hanging

NEW YORK, Jan. 19—An attorney for a Westchester County family whose son was found hanged in a jail cell has pressed the FBI to investigate all of the alleged suicides by hanging of Black prisoners in the Yonkers city jail.

According to the Jan. 19 Amsterdam News, the Westchester County District Attorney cleared the Yonk-

ers city police of any wrongdoing in the death of Barry Parsons. Parsons was reportedly found hanging from his underwear tied to a cell bar.

Relatives assert Parsons was beaten to death and that two witnesses saw police hit Parsons during his arrest.

Family attorney C. Vernon Mason said, "We have a question as to whether marks around Parsons' neck were caused by his underwear. Our investigation shows that there have been other Black men who died in the Yonkers city jail under similar circumstances."

Referring to the DA's decision that no misconduct or criminal behavior on the part of police was involved, Mason said, "I don't see how the DA arrived at this determination. We have witnesses who saw the beating of Parsons. I don't know what the DA means when he says that they were cleared of wrongdoing."

## Anti-war activists sentenced

JANUARY 19—Seven anti-war activists have been sentenced to serve indefinite terms in jail until they

promise not to protest. They were arrested Dec. 3 for blocking the entrance of the Williams International "defense" plant in Walled Lake, Mich., where cruise missiles are manufactured. The seven refuse to agree to give up their protest and have asked Amnesty International to recognize them as prisoners of conscience. Demonstrations and blockades have continued for almost two years against this war merchant. Police have made 93

prison.
While strapped in the chair, Raulerson calmly read from a sheet of paper, explaining that Officer Stewart's death was the fault of the

"James English killed Michael Stewart (the slain police officer) and used Stewart's gun to murder my cousin," he said.

Officer English was at the same moment standing in a pasture outside the prison in a gang of more than 60 Jacksonville cops demanding his execution. A group of 30 people nearby protested the death sentence.

The cops, some wearing T-shirts with a drawing of the electric chair and the words, "Crank up Old Sparky," cheered when the execution was final.

The United States Supreme Court had denied Raulerson's appeal for a stay. Florida officials immediately sent Raulerson to the chair making him the 11th person in Florida and the 37th person in the country to be executed since the Supreme Court reinstituted capital punishment in 1976. The tempo of executions is quickening. Almost two-thirds of death row inmates are in the South, particularly Florida, Georgia and Texas.





- Reagan's assault on human services

Sam Marcy on: Class conflict and the budgetary crisis

FEBRUARY 5—In the coming days
and weeks the capitalist media will
saturate the people with talk concerning the federal budget and the "long,
protracted and complicated budgetary
process."

Actually, from a working class point of view there is not one budgetary process but three. Although the three are intimately interrelated, each should be examined independently in order to bring out its true significance as far as the mass of the people are concerned. The budgetary process to which the ruling class, the capitalist politicians, and the media refer is the purely legal, procedural and parliamentary aspect of pushing through a budget.

In reality, this is the superficial aspect of the budgetary process. It is the aspect which hides the real process, which is a social process.

Capitalist state: collective exploiter of the people

To understand this, one must look at the relationship of the basic classes in capitalist society. This is a process by which the capitalist state in its role of the collective exploiter and oppressor of the people collects, or to put it more accurately extorts, from the mass of the workers and the people generally that which the individual capitalist exploiter cannot directly expropriate from the workers. The capitalist state in its role as the collective agent for the ruling class expropriates the rest of what is left and distributes it among the various ruling cliques through what they call the budgetary process.

In addition the capitalist state also adds an onerous form of extortion through taxes against the people while exempting from this taxation most of the ruling class who at best only pay a token amount.

token amount.

The budgetary process is therefore a means for dividing up the surplus value created by the workers and distributing it among the most predominant monopolist ruling groups. In this role, its economic role, the state can only superimpose upon the individual, direct exploitation of the working class, the collective, indirect exploitation by the collective exploiter of the ruling class—the capitalist state.

organization of masses

The third aspect of the budgetary process involves the mass of the people, the working class and oppressed and how they are organized in the struggle against this extra form of capitalist exploitation.

The bourgeoisie attempts to present the budgetary process in a narrow and purely procedural way so as to hide the actual social class content of the economic process, that is, of the relationship between the exploiter and exploited as embodied in the capitalist state. The Constitution of the United States, Article 1, Section 7.1 states: "All bills for raising revenue shall originate in the House of Representatives." Is that what really happens in contemporary times under the domination of finance capital, giant multinational corporations and the military-industrial complex? Not at all.

Who develops the real budget?
The real budgetary process is initiated, discussed, worked upon and developed by about 25 and at most 30 of the biggest Wall Street and Washington law, accounting and tax specialist firms which represent the most powerful interests of the largest and mightiest of the financial, industrial and military corporations of the U.S.
These servants of the ruling class

have the most intimate connections with the White House, the Internal Revenue Service, the Treasury Department and key members of the Senate and House of Representatives. They are not subject to any electoral process. They are retained on long-term contracts, retainers that is by the giant

monopolies.

These so-called big name law, accounting and tax specialist firms know well the intricacies of governmental processes as they relate to taxation and the appropriation of money. Representatives of these law, accounting and tax firms and government officials literally know each other on a first name basis. The bourgeois elite among the country's top accounting and law firms are tied by a thousand threads to the highest government officials, whether they be in the White House, Internal Revenue, the Treasury or whatnot.

Most of the representatives of these law and accounting firms have in one way or another served in key capitalist governmental agencies including the House. They go back and forth from these departments with the ease and facility with which one might travel on a train or plane.

Thus when you hear that a giant corporation like General Dynamics, just to mention one out of several dozen, hasn't paid a cent in federal taxes since 1972, it's precisely because the agents in these giant law and accounting firms are paid fat fees to maintain an intimate connection with the capitalist government while seemingly remaining aloof from it.

What individual Representative or Senator could even hope as an individual to go through the ten thousand and one items that are supposed to be listed in the budget? Only a giant firm could do that. Only a financial organization with hundreds of employees and intimate governmental connections over a long period of time and experience with Democratic and Republican administrations can manage such a

can manage

wields the most powerful influence as servitor for the big bourgeoiste, the finance capitalists who fleece the workers and the oppressed.

What then is the task of the Congress as revealed in the actual framework of class relations and not merely as they are superficially and fraudulently represented through the purely procedural aspect of the budgetary process? It is more that Congress is increasingly reduced to the level of a talk shop while the real work is carried out behind the scenes, and the role of the people is not taken into account at all except in those cases where the ruling class becomes fearful of genuine mass pressure exerted from below.

What is the quintessence of the ruling class' budgetary problem today? It is how to put across the Reaganite budget. This budget is a truly horrendous form of expropriation of the savings of the masses and of further intensifying the exploitation and oppression of the masses in such a way as to give the appearance of having arrived at a consensus of the people.

Thus a whole lot of complicated maneuvers are now going on in which a whole variety of capitalist politicians from the extreme right as well as among the liberals allegedly vie with each other in cutting down or reducing the budget.

In reality, however, while dozens upon dozens of Congresspoople are scurrying to their districts and whole regions presumably to get input into the budget, a rotten compromise has already been achieved behind closed doors in order to obtain the so-called necessary trimmings of the budget so that at the end of the process it will appear that a good, hard fight was put up against the Reaganite mass expropriation of the people. Of course, the bulk of what the Reaganites and especially the Defense Department asked

to increase defense expenditures?
Listen to that most liberal Senator, William Proxmire from Wisconsin, and Representative Pat Schroeder from Colorado who were both asked to respond to Defense Secretary Caspar Weinberger who presented the Reaanite military budget—the largest, most unprecedented in U.S. history. Asked to define the issue as far as defense expenditures go by Sandy Freeman on Cable Network News (CNN) on Jan. 30, Proxmire replied that the issue in Congress is "not whether to reduce expenditures. I want to make that clear. I know of nobody outside of perhaps Jesse Jackson or George McGovern, neither of whom are in Congress, who would reduce defense expenditures. The real issue is how much to increase defense expenditures. We are for about 3% and the administration is for about 7%. So it lends itself to a consensus and compromise."

There it is in a nutshell. First of all the real issue as defined by Proxmire (and he should know because of his long time in Congress) is not how to reduce the burden of the gargantuan war budget but by how much to increase it.

Rep. Schroeder, who like Proxmire sits on one of the armed services subcommittees, agrees with him. "No one," she says, "wants to weaken our defense. We want to strengthen it." But again the question is by how much.

## ð eagan offers military-industrial huge handout complex

for the Department of Energy's hydro-

gen bomb and nuclear warhead production line, \$1.16 billion for the Grumman Corporation's contract on F-14 Tomcat fighter planes, \$6.2 billion for 48 more B-1 bombers, \$39.3 billion for research and development, 15,000 more sailors for the Navy and 13 new surface ships, 10,000 more airmen along with additional C-5 and KC-19 cargo planes, a rapid-deployment "light" division for the Army and 144 Apache attack helicopters, 840 new M-1 tanks and 716 Bradley fighting vehicles.

"Secretary Weinberger feels," according to a statement released by the Pentagon, "that those who hope for success in bringing down the defense budget really mean success in weakening the security of the country."

What Secretary Weinberger really feels is that he can shut up any opposition to this grotesque \$313.7 billion war budget by red-baiting smears and flagwaving hints that those who don't go along are secret traitors.

Now as far as the Democratic Party politicians in Congress are concerned, none of the leaders there are even suggesting a **cut** in military funding, but only a slightly smaller rise in the rate of **increase**. This is the position of Jim Wright (D-Texas), Tip O'Neil (D-Mass.) and so-called Republican moderates like Bob Dole (R-Kan.) as well.

All are either unwilling or unable to stand up and really resist the rich defense contractors, the generals and admirals, and the Reaganites who serve them. In effect, the legislative branch has been turned into a kind of rubber stamp for whatever the military-industrial complex demands.

Whatever pressure the members of Congress are under to swallow these wild "requests" from the Pentagon, it does not come from the majority of people who have shown in one public opinion poll after another that most believe military outlays are already far too high.



Should not attention be focused, indeed riveted, upon a majority of the House which promised to fight the Reaganite budget? Should not atten-


rotten, reactionary and racist compromise on the Reaganite budget? Without in any way cultivating parliamentary illusions regarding the nature of

In addition, stiff new user fees will become the norm for federal services. For example, the IRS will charge you \$100 for private tax rulings, fees for using national parks will rise, meat and poultry inspection will require a fee, etc., etc.

Cut in federal workers' pay
Included in the plan is a 5% salary
cut for all federal workers, the first
such pay cut in recent history. This cut
not only affects federal workers
and their families, but will have a
negative impact on the entire economy
by reducing the buying power of the
largest group of workers in the country.
Another devastating effect will come
from the elimination of urban mass
transit aid. Mass transit officials

across the country were surveyed about the cuts by the American Public Transit Association, which found that

an immediate, unavoidable and massive decline" if Reagan gets his way.

In Chicago, officials warned that the cut would mean they "could quickly face a shutdown crisis" and New York City officials immediately warned of a major fare hike and further service reductions on the deteriorating subway and bus lines. The transit association estimated that the loss of the federal subsidy would mean the elimination of 203,000 jobs nationwide from service and construction cutbacks.

Another vicious blow is a 28% cut from the Labor Department's Employment and Training Administration and the complete elimination of the Job Corps. Reagan's first year in office marked the death of the CETA program, the last large scale jobs program, the last large scale jobs program, and jobs programs have been treated like some kind of disease by the administration ever since.

These final nails in the coffin of job training and placement assistance come right after news that unemployment rose for the second month in a row. While Reagan's figures show that unemployment rose from 7.2% in Dependent of 7.4% in January other cone
